



ABOUT THE ORGANIZATION

BACKGROUND & BRIEF HISTORY

The district of Sundargarh with an area of 9712 km is the second most expansive district in the state of Odisha. It's Schedule Caste population accounts for 50.69% of the total. The cultural profile is prominently rural and tribal. Over 66% of the population permanently settles in 1744 colorful villages dotted across it's territory. The district is exceptionally rich in natural forest (43% of the land is under forest cover), mineral, land and water resources, but this profusion hardly ever reveals itself in the lives of it's illiterate and unskilled rural folk who merely survive as poor and vulnerable communities.

A group of youth from different parts of Sundargarh district, inspired by the then Youth Coordinator of Nehru Yuva Kendra Sundargarh Mr. Gopal Chandra Ojha started working collectively in 1995. With the support of the DRDA through the NYK Sundargarh few skill development training programmes for the rural youth, plantation and nursery rising, formation and promotion of SHG groups were the initial activities by this group. Legal status of the organization

 IGR Registration No: 21907/85 of 2004-05, Registered by Registrar of Societies, Orissa, Cuttack under Societies Registration Act XXI of 1860, (Against Sundargarh District Registration No. SDG- 1407/32 of 1995-96/, dated: 15-05-1995). Sundargarh was developed, as the center for all these activities. On 15th May1995, SEWAK was registered under the Registration of Societies Act, XXI of 1860 at Sundargarh. Later during 2004-05 it was rgistered under IGR, Cuttack. Gradually by 1998 SEWAK Complex became the center of excellence for youth services in Sundargarh. SEWAK was the destination for more than 300 youth organizations.

Up to 1998 NYK Sundargarh was the resource mobilizer for SEWAK. With the transfer of Mr. Ojha to other district as the Youth Coordinator this chapter closed. The SEWAK management then struggled for resources. But the coordination with the district administration and the linkage with the Youth organizations in different parts of the district helped them to survive. During 2005 SEWAK came in contact with the Concern Worldwide India, Bhubaneswar, a Dublin based INGO which was a turning point for the organization. The handholding support provided by this organization really given a professional touch to SEWAK.



LIVELIHOOD & GOVERNANCE SECTION

Energizing MGNREGA...



The project entitled "Energizing MGNREGA in Odisha" commenced under the guidance and support from Concern Worldwide India in April 2012. FES (Foundation for Ecological Security) was the nodal organisation at the state level. The project covered 2 landscape areas of Sundargarh district i.e. Meghdega in Tangarpali & Ekma Land scape in Bargaon. There are 13 Revenue villages of 3 CD Blocks. The main objective of the programme is to demonstrate effective implementation and roll out of MGNREGS reform and ensure higher livelihood return for extreme poor families in the project area.

Major Achievements:

- One Land Scape plan developed (5575 Hact. Area)
- 2560 nos. of MGNREGS shelf of activities included in PalliSabha
- Meghdega Land Scape plan is approved by Gram Sabha on 18th October 2012.
- With convergence of the MGNREGA & FRA 161 title holders are able to create individual assets like farm pond and developed their lands through land development scheme.
- 54 FRA title holders received work order for preparing compost pits, cattle sheds, goat sheds, poultry sheds and land development under MGNREGA.
- Women participation increased in Palli Sabha and Gram Sabha.
- Migration is reduced from the project area (482 nos. in 2005 where as 71 in 2012)

Effective realization of CFR......



The project entitled "Effective Realization of Community Forest Right" commenced under the guidance and support from Concern Worldwide in India in April 2012 with the leadership of VASUNDHARA, Bhubaneswar in a consortium. The project coveres49 revenue villages in 9 Gram Panchayatsin 2 blocks of Sundargarh district named Tangarpali & Badgaon in. The major activity activities of the project were a campaign on Community forest Right (CFR), building capacities of local youths & Forest Right Committees, developing FRA convergence model.

Key Achievements:

- 22 CFR claims submitted to SDLC Sundargarh.
- 49 nos. of Village and Hamlet level aware meeting organized in the project area on new FRA amendment rule 2012, Community Forest Right and Community Resource Right.
- Convergence made for 161 FRA title holders with MGNREGS farm pond & land development programme in the project area.
- 60 nos. of FRA title holders received work order for Indira Awas Yojana.
- 2 nos. of district level consultation was organized on Community Forest Right & Community Resource Right.
- 2 nos. of Joint Palli Sabha organized to fill up the application form of Community Forest Resource Right (Form-C) in Tangarpali & Badgaon block

Social Audit.....



In Sundargarh, a significant initiative was taken by the district administration led by Mrs. Rupa Roshan Sahu (IAS) Collector and District Magistrate regarding MGNREGS and Social Audit in the year 2012-13. SEWAK was selected as the Nodal NGO to coordinate the Social Audit Process in the district. A Social Audit Team (SAT), comprised 102 members was developed. SAT and Chief functionaries of NGOs were oriented on Social Audit Process.

INNOVATIONS

- Miking in every village and hamlet level.
- Every Gaon Sanjojak was responsible to gathered at least 20 Job Card holders at the Social Audit site.
- Folk media show on MGNREGA and Social Audit
- A central monitoring team of NGOs developed
- Social Audit was organized for 2 days (1 day for Field verification and 1 day for Public hearing).
- The entire process of social audit including proceedings were documented bythe NGO representatives as an external facilitator.
- Proposed Action taken report was compiled by social audit facilitators.
- Media coverage on regular basis.

ACHIEVEMENT

- Due to Social Audit most of the records were updated before one/two days.
- Most delayed payment cases were settled just before social audit day.
- Improvement in Participation of ward members and members of vigilance & monitoring committee.
- Through this campaign mode of social audit, all related officials of GP and blocks are being alert.
- District Collector and Project Director, DRDA were directly involved in the process.
- Better experience on Convergence with G.O. and NGOs for different Govt. schemes.
- It creates a strong human resource team for the district.
- A sum of Rs.1.85 lacs recovered from EOs, JEs & GRS as penalty by Social Audit Gram Sabha.



UDIAN TARA- A CASE STUDY

Sundar Hess, age 50 lived in Gailjore village of Meghdega GP in Tangarpali block with his wife, four daughters, one son and his old mother. The major occupation of the family is daily labour, agriculture and collection of the forest produces. He had no land of his own, only 4.25 acres are there in forest land.

In the year 2007, due to unavailability of work he is migrated to Starlight Jharsuguda (2005-2007). His two daughters migrated to Gujarat (2007) and his wife worked as the agriculture labour. During this period he had faced lot of challenges in his life likeharassment at work site, low wage payment, poor quality of food at Gujarat, bound to sail PDS rice in case of emergency, food scarcity (2-3 months), no money for education of children.

In the mean time SEWAK made intervention in the area and do the following activities

- · Formation of Forest Right Committee
- Form fill up for land entitlement under forest right act
- Facilitate Joint verification, land demarcation, Gram Sabha
- · Facilitation for new Job Card
- Facilitation for Timely payment in MGNREGS
- Facilitation for Social Audit
- Convergence programme- "Mor Jamin Mor Jibka"

As a result....

- Sundar Hess & his family members worked under MGNREGS regularly.
- He was able to earne Rs.78,000/- through MGNREGS in last 4 years.
- . He was able to purchase a bicycle.
- He was able to save Rs.10,000/- in the Bank.
- Sundar Hess got 4.25 acres of Land under FRA.
- He got a farm pond (Rs.35,000/-) under "Mor Jamin Mor Jibka".
- He was able to purchase 01 pair of bullock.

Breaking the cycle of extreme poverty......

Since 2007, with the support of the Trickle Up, New York the Trickle Up programme has been implemented in different blocks like Tangarpali, Lephripada, Balisankara & Bargaon blocks of Sundargarh district. Now the programme is being implemented in 4 GPs of Bargaon block in 13 villages and 21 hamlets. 300 programme participants are being covered through the programme. The main objectives of the programme are as following:

- To target people who live in extreme poverty.
- To reduce the participants' vulnerability to shocks and trends.
- To increase number of livelihood activities and diversify income sources
- To enhance skills and knowledge of participants for carrying out sustainable livelihood activities.

Under the programme the selection of the programme participants is followed by some specific criteria and the major agenda is to find out the ultra poor in the area and support them with an amount of Rs. 11, 280/- per annum in three specific sectors i.e. Agriculture, Livestock & Small Business. Along with the monetary support some capacity building inputs are also provided to the SHG members on good health & hygiene practices.

Major Achievements

- Out of 300 PPs 35% PPs earned profit above Rs 22,000,15% earned profit above Rs 15,000,20% earned profit above Rs 10,000,11% earned profit above Rs 8,000 & 18% earned profit above their investment.
- With an investment of Rs 31, 06,726 earned profit amount is Rs 53, 84,196 from the agriculture, livestock and small business activity.
- 70% PPs adopt Vegetable cultivation as the primary occupation (35% at baseline agriculture as paddy cultivation).
- 75 numbers of PPs adopted small business activity and get profit average Rs 11,000.

- Due to Trickle Up intervention PPs were able to purchase household asset and productive asset to improve their living standard in the society.
- Livestock increased from 1192 to 2206.
- 22 numbers of SHG saved Rs 6,44,823 and inter lending amount is Rs 13,10,826.
- 50% (11numbers out of 22) of TU SHG credit linked from the Bank Rs 5,00,000/
- 17 numbers of paid accountant recruited for sustainability and smooth functioning of SHG.
- Signature of member improved from 17% to 88%.
- 17 number of collective actions taken by the SHG against the alcoholism, domestic violence etc.
- 172 household covered under MGNREGA and 6346 person-days generated during the last financial
- Out of 24 widow women 09 get widow pension benefit during the project.
- 11 PPs benefited with IAY House and 16 PPs get land under FRA.
- 73 PPs identified as pregnant & 98% registered
- under Health Centre in 1st Trimester of pregnancy.

 Institutional deliveries increased from 18% to 93%.
- To improve child health and mortality rate 54 children provided 100% age appropriate vaccination those were completed 2 years within project period.
- Proportion of participants visiting a PHC / Subcentre increased from 22% to 86%.
- Use of mosquito nets increased from 7% to 86% and adequacy of nets increased from 59% to 92%.
- Use of permanent or temporary family planning measures increased from 29% to 52%(Out of 133 total dane 69)
- To improve dietary intakes 63% of PPs adopted kitchen garden & 94% PPs having tricolored food at least twice a week after the project intervention.
- Food intake capacity increased from 5% to 90 %.



"We can change our family ourselves"

Sambari Ekka a female project participant of Trickle Up belongs to Bazzarpada, Ekma village under Sundargarh district. She lives with her husband and 3 children. After marriage her father in law separated them with her husband due to their love marriage. Before the TU intervention her family depends upon the wage earning. She was selected as project participants of the program on 2010 & motivation by the staffs for Income Generation Activity .They create a proper livelihood plan for agriculture facilitation by the TU staffs.

In their village some people cultivate Chilly, but they could not produce enough to make a good profit and she was also not able to do so, due to lack of capital. So, the project supported Rs 11,280/-and provided hand holding support in their village. She could learn new cultivation processes, suitable pesticides and fertilizer use, line sowing, and identification of better varieties of seed. After undertaking the training she cultivated chilly in a small patch of land in the 1st year. She earned twenty one thousand rupees out of the chilly cultivation. She purchased a water pump, 2 goats and depositedRs. 5000/-at SBIBargaon for the future plan of agriculture. In the next year she diversified the cultivation fromchilly to pumpkin, barbati, bottle guard, sun flower, and pea nuts to earn more. This year she earned 35,846 rupees from agriculture .Till date she earnedRs 62,418/-. Now she is planning to do more in the next season. She is also planning to construct a house this year and manufactured 50,000 bricks. She expressed that, "The confidence generated by this project helped my family to earn a lot". Many think cultivation is not remunerative, but for me it is a good livelihood option for me.

Leave Liquor a local campaign...

Context: Village Khandiamunda was usually gets crowd by drunkard at dusk regularly. Few years ago this village had notoriety in Deogarh District for Mahuli business (Country liquor). People make friendship with liquor and treated their spouse as enemy during every night. Since quarrel of parents last till midnight children within the family never felt secured. This was the miserable situation of the village three years back. The main ill effects associated with liquor were loss of employment, family disruption, insolvency and non-cooperation to function of VSS. In this situation the concept i.e. democratic function of VSS and restoring degraded forest was meaningless for them. Even though partner NGO SEWAK (CBSA) was not assigned to work against the issue alcoholism however the situation persuaded them to sensitize people in terms of enhancing capacity of VSS that the noble job assigned by OFSDP.

Introduction: The process of problem identification was not merely intellectual in character. There was a strong emotional element because pain, suffering and sharing of hardship were involved. CBSA felt that alcoholism was one of the root causes that create bottleneck for participatory development and function of VSS democratically. A few people approached CBSA and said they wanted to do something about the problem of alcoholism. Taking their approach as an opportunity CBSA suggested various forms of social action but did not initiate any measures directly in their village. In the due course of time inbuilt confidence boosts them to search for different avenues of income instead of the worst occupation liquor business. Now a day's community engaged in different income options with receiving support from OFSDP through their VSS and women self help group.

Depiction: VSS of Khandiamunda has proved their potency in creating multifarious agri based income avenues for all 18 families resides. Liquor business was major occupation of people considered till late 2009. Every month a few leaders of the community and CBSA training organisers hold a meeting. At one such meeting CBSA presented the perceptions and experiences of alcoholism and found that the messages were widely shared. People realised that this is the problem and without solving this issue VSS cannot survive and whole community will be deprived from all sorts of benefits planned by forest department. Once a gathering of 14 numbers of VSS and SHG members took an oath to abstain from alcohol and succeed. VSS create a cultural team and disseminate the message against liquor. Nowadays this VSS is one of the best VSS in Deogarh forest division.

Key learning: Saving is the current expenditure in turn that yields income for future. During our discussion VSS was asked how your existing occupation mainly agriculture and allied business compensate the high profitable liquor business. VSS president Mr. ChaitanyaPradhan ridiculed our question and saying that they would take better care of themselves if they retain more of their money.

Conclusion: Necessity is the mother of inventions. While people felt that how liquor business badly influence their day to day life they searched different options for their livelihood.VSS and SHG proved their roles in bringing changes in the life style of community.

NUADIHI VSS

Nuadihi VSS was established during 3rd phase of OFSDP. This VSS having good in plantation (48 ha) with ANR 30 ha, Economic 1 ha, Fuel Fodder 2 ha, Bamboo 1 ha, and NTFP 14 ha. This VSS is dealing with 5 WSHGs one of them is MANINAGESWARI BALIKA MANDAL. This WSHG struggled a lot for loan and lastly State bank of India denied giving loan.

The Nuadhi VSS keeping their interest in mind sanctioned the loan from VSS revolving fund the sum of Rupees 10,000. After that the WSHG prepared phenyl and marketed in Bonai, Sundargarh, Bhubaneswar. Mr. Santosh Banchur (DFO, Bonai) visited the WSHG and taking steps for the growth of the WSHG and linked with Maa Sharda Mahila SHG Udoyag (Sambalpur), Owner of Maa Sharda Mahila SHG Udoyag Sri Maheswari organized training program to improve the quality of products.

After getting training the quality of phenyl has increased and the rate of phenyl also increased (Rs. 40/- per liter). Now they are earning rupees 10/- per liters as benefit. Now a day the phenyl has a good demanded in the market. MaaSharda Udyog getting an order of 5000 liter phenyl for every month. In the month of January 100 liters phenyl was sold in Sambalpur Lok Mahotsav and also marketed in Bargarh DhanuJatra.

Promotion of WSHG

One can find a SHG in each and every village of Odisha. But at the same time one can find the women members of the poorest of the poor families are not a part of these SHGs. Keeping this in mind during 2013, SEWAK join hands with NABARD, Sundargarh for implementing the "Promotion and linkage of WSHG in backward district" programme in three blocks named; Lephripada, Bargaon and

Kutra of Sundargarh district. The main objective of the programme is to promote & link150 new Women SHGs in these three blocks.

Major Achievements:

- 40 no of WSHGs formed in Lephripara &Bargaon block.
- 460 women are included in WSHG.
- 40 SHGs bank linked.

The number of Men having sex with Men (MSM) and Female Sex Workers (FSW) is not small in and around Rourkela steel city. To provide this population a comprehensive package of preventive services and to secure their lives before they fall victim to HIV/ AID, SEWAK join hands with the Odisha State Aids Control Society (OSACS) in the year 2008. 500 MSM & FSW are identified in Rourkela city and its periphery.

The major project deliverables are BCC, STI treatment, Condom promotion, linkages with other services, community mobilization and enabling environment.

With some burn injury Trupti Mohanty(one female sex worker) on dt.02.02.2013 was admitted at Rourkela Government Hospital (RGH). On dt.03.02.13 her husband called to E. Laxmi Rao (Peer Educator) that hospital authority is not supporting her and refer to V.S.S Burla.

Laxmi Rao informed this to the TI project. The TI team report edit to "PRERANA" CBO to look after the matter. The CBO members reached at RGH and interacted with the client. She had a burn injury of $20\text{-}25\,\%$.

Actual reason is that, the service providing staffs of RGH were not taking care of the patient as she was a HIV +ve. On the other hand concern CMO of RGH committed the CBO members for quality service. He suggested to the care taker of the patient to produce income certificate for free medical treatment and medicine.

Supporting documents were given. At last she got service from RGH.

NRHM, seeks to address the gap through establishment of Urban Slum Health Centers on PPP mode that could provide:

- Basic RCH preventive care, such as Antenatal care, Immunization, vitamin A, Birth-spacing, Reproductive tract infections (RTI), and Sexually transmitted infections (STI)
- ii) Referral for high-risk pregnancy and newborn emergency, and outreach services.

SEWAK is running a Tier-2 Urban Health Centre (one of 3 such centres in Odisha) at Tilkanagar, near Bondomunda in Rourkela. Begun, on 1st November, 2007 as a Tier-1 UHP, it was upgraded to Tier-2 in the subsequent year. Now, the Centre makes available a wide-range of health related services, such as, OPD, referral, laboratory testing, awareness generation, community mobilization, BCC, health camp, adolescent training, social marketing, etc. to 23004 people inhabiting in 18 slums of the area.

CHIN is a network of five national level NGOs and is funded by the Bill Gates and Malinda Foundation of USA. The progamme seeks to reinforce NRHM by building up capacities of different stakeholders so that adequate demands could be generated for service on one side and commencement of prompt service delivery on the other. During the two years intervention, certain changes have been made in the project area and also at the target group: Major Achievements:

- 1) Sub-centers are opened by ANMs on regular basis.
- Follow-ups and monitoring are constantly conducted by the MO/IC, Mangaspur.
- A larger section of women SHG members, pregnant women, local youth, adolescent girls possess good knowledge of NRHM health entitlements, like GKS, RKS, JSY, Janani Express, and its scope in rural areas
- 4) Door to door home visit by ANMs & ASHAs accelerated after intervention
- MO/IC conducts frequent instance meetings to verify drug distribution status in the community by ANMs
- 6) A Medical Officer appointed as a result of lobby by community at Mangaspur CHC
- 7) CHIN intervention brought qualitative change in VHND organization; ASHAs, AWWs and ANMsorganize the event punctually
- Increasing involvement of PRI members in facilitation of NRHM entitlement recorded after intervention
- CDMO officially agreed to ANMs' appointment against the existing vacancies in health sub centers at
- 10) CDMO also openly committed to take steps to bring a drastic change in the behaviors of Doctors and ANMs towards the patients and their relatives
- 11) Reclamation of 22 Swasthya Kantha (Instruction Walls) with regular updating by service providers
- 12) Changes in GKS Village Health Plan preparation with active Youth Participation
- Certificate awarded by DPM, NRHM, Sundargarh and BPO, Tangarpali to project staff on grounds of outstanding performance in the field

A STEP TOWARDS CHILDHOOD CARE

Manguli Kalo is an 18 years young lady. Her parental village is Rupabahal. She has two brothers. She was living with her family. During this time she fell in love with a young man namely Pahada Kalo and eloped with him on 2008 They lived together for one year at Gaydega.

When her husband came to know, Mangui was pregnant then he left her. As because he was avoiding his responsibility to look after his family, now he is out of station. Then Manguli came to her parental house. But unfortunately she didn't get support from her family .She continued to live at a separate house in the same village. At present she is having a 09 months child. Her child's health condition is miserable, as that kid is not getting adequate breast feeding. She has no money to buy medicine and to have regular medical check up of her child. As she did not get recognition or sympathy from the society, she continues to live in a suppressed manner. She never attended the Mamata Divas & Prusitkar Divas

The HW (F), ANM, ASHA, convinced her to send her child to Prustikar Divas and Mamata Divas. They also reffered the case to Prustikar Divas. At the time the weight of her son was 2.5kg in the month of (4month). She received medicine and take care her baby. But after some days she went to other place with her husband and she became irregular with her child's treatment.

During the awareness meeting the staff of Chin for Change visited Manguli's home and counselled her. After continuous persuasion, Manguli is now attending the Mamata divas and Prusitkar divas. The AWW & ASHAs are looking after the mother and child, now we feel the child is improving day to day.

How challenges are handled:

- Continuous home visit.
- Motivation to her mother.
- Provide free medicine from AWW&ANM.
- Good communication relation.

Status after intervention / Present status and impact:

- Good health condition.
- Regular attend the VHND.
- Regular contact with ANM, AWW&ASHA.
- Her child is improving with his health.
- Now she is cured from mentally disorder.

SEWAK is working as a partner of Lepra Society to implement the Axshya India GF9 TB Project in October 2010 with the objective to improve the reach, visibility and effectiveness of RNTCP through civil society support by engaging communities and community based care providers for improving TB care and control, specially for marginalized and vulnerable population including TB-HIV patients.

SEWAK is implementing the programme in 02 TB units named Sargipali and Sadar which are having 6 blocks in the district and the target population of the project are all the stake holders, patient as well as the service providers in Sundargarh District. Major objectives of the project are:

- To increase the awareness level of the community Members, i.e. WSHG, GKS, CLUB on RNTCP through increase incase detection and case holding.
- Developing basic Knowledge on TB, its sign and symptoms.
- Create awareness on the facility available on RNTCP.
- To make a clear understanding of the community members through participation on RNTCP so that there will be increase in case detection, early treatment and complete treatment.

RastriyaSwasthyaBimaYojana (RSBY) is lunched in Sundargarh district since 01.01.2012. Maximum 5 persons in a BPL family will get this benefit. The BPL family have to pay Rs 30/- towards insurance charges in a year and will get health benefit of Rs 30,000/- in a year. A Smart card is provided to the member at the CHC level. The RSBY help desk is being installed in every CHC.

The smart card holder get the RSBY Benefit for indoor treatment for at least 24 hour admit and Transport allowance @ Rs.100 per visit upto maximum of Rs 1000.

SEWAK has deployed man power to 11health institutions. One Protocol Manager and One Data Entry Operator are engaged .At the Sub Divisional Headquarter level one Protocol Manager and Three Data Entry Operators are engaged.

- 13,800 lactating and pregnant mothers were oriented through Focus Group meetings
- IEC materials in shape of Flex, Pocket calendar and calendar are distributed among the stakeholders.

Since 12th June 2012SEWAK the support of the W & CD Department, Govt. of Odisha, to implement the SABALA Training in 21 ICDS Unit of Sundargarh District in 82 batches in a networking mode with 15 partner NGO (40 nos. of Part time Resource Person) in Sundargarh district. The objective of this scheme is to improve the nutrition and health status of girls in the age?group of 11 to 18 years, to equip them to improve and upgrade their home?based and vocational skills, and to promote their overall development, including awareness about their health, personal hygiene, nutrition, family welfare and management.

Vitamin A Programme



Vitamin A deficiency can cause blindness, impair health, and be an underlying cause of death, in young children. Vitamin A supplementation programmes do effectively and safely reduce child mortality.

In Sundargarh there are many remote areas where many children were being deprived of vitamin A supplementation. It is also realized that, awareness level on immunization and

supplementation of vitamin A was seriously lacking among the communities. They are only aware of polio vaccination. Thus SEWAK with the support of Unicef carry out the Vitamin A supplementation programme in 05 blocks which are most remote, Vulnerable, Tribal dominated. They are, Koira, Lahunipara, Lathikata, Bonai and Nuagaon blocks.

EDUCATION SECTION

Ensuring quality education (Shikshya Chetana Programme)

Education is always a neglected area in a tribal populated district like Sundargarh. Thus the quality education at the primary level is not in a good position. To ensure quality education at the primary level, SEWAK has been involved in a Education related programme named "Shikshya Chetana" in the year 2008 with the support of Edukans Foundation, Netherland. The programme is being implemented in a network of 8 partner organizations in Sundargarh & Keonjhar district.

SEWAK is implementing the programme in Meghdega & Gambharidihi GPs of Tangarpali block. The major objectives of the programme are:

- To ensure 100% enrollment and retention of 6 to 14 years children in the schools with the community participation
- To strengthen & motivate civil society organization to make the village people understand the importance of relevant quality education
- To facilitate lobby & advocacy at panchayat and block level to bring about policy changes in the present education system

Major achievements

- 2000 children got enrolled in formal schools
- 490 non enrolled and drop outs youngsters received livelihood skill training in 29 livelihood trades
- 3500 parents motivated towards enrolling their children in schools
- 1050 school going children received life skill training at the school level
- 1500 children involved in the Village, GP & Block level child clubs/federations
- 252 SMC members are oriented on Right to Education Act, 2009

A REAL PATH MAKER

Few years ago, Tinkuda village surrounded with hilly mountains had no communication facility. There was no electricity connection. There are 254 number of household with the population of 1248. Most of the people are of Scheduled Tribes.

A young lady named HarabatiBadek is also residing in the village with her parents, three brothers and sisters. Due to poverty she could not continue her education from class 7th. After some years in 2007, she joined a SHG group called 'MaaTrilokyaTarini'. With her leadership the group performed good and awarded by several departments. But in the other side, the education scenario of the village was much neglected. The parents of the children were not aware of education and several children remained in the village as drop outs and non-enrolled. There were many irregularities seen in the school including the school grant, teaching process, teacher absenteeism, student admission & retention etc. Along with those irregularities there were more than 30 drop outs and non-enrolled youngsters remained unemployed in the village and also getting misguided.

In that crisis period, SEWAK implements it's education & livelihood based project named 'Shikshya Chetana' in Tinkuda village for the ensuring quality education and mainstream the youngsters by providing them livelihood skills. To fulfill the objective of the programme Harabati Badek came forward as the support provider. After receiving some trainings she was confident and started to convince the parents to send their wards to school and also she made a survey and door to door visit of the drop out children and brought back them to school. The Ex-Head Master of the school had made some irregularities with the school grant fund and it was Harabati who raised voice against that issue and with the intervention of SEWAK and support of the members, the respective person had reimbursed the fund and settled all the accounts of the school.

Along with that, she also prepared the database of the unemployed youngsters and in her supervision they had received the livelihood skill in the village by SEWAK.

Now the school is functioning well and all the children are enrolled in the school, Harabati regularly vising the school, monitoring Mid-Day Meal & participating in all meetings of the school.



Ensuring child rights.... Child Rights & You (CRY) Project

With a goal of ensuring overall empowerment in the education and health status of children through community involvement, SEWAK is implementing the Child Rights & You project since 1st July, 2011 with the support of Child Rights & You (CRY) Kolkata. The project is being implemented in Sarafgarh & Masabira GP of Lephripara block covering 2274 households. The targeted beneficiaries are:

- 0 to 18 years children
- 6 to 14 years drop out &non enrolled children.
- Pregnant & Lactating mothers
- Janch Committee members
- SMC-Members

Major achievements of the project:

- SMCs in 11 schools of the project area are conducting their meetings properly.
- 09 Janch committee members are functioning well at the AWC level.
- Four malnourished children referred to Sundargarh NRT centre.
- In 06 GKS the GKS funds are utilised properly
- Developed 36 cadres from the community
- 25 Cleft lip children successfully operated at Hi-tech Hospital Bhubaneswar supported by Operation Smile.



THE LOCK OF THE ANGANWADI CENTER WAS BROKEN AFTER 1 ½ YEARS

Bichhuabahal is a remote village in Lephripada Block of Sundargargh district. There are 150 house holds with a population of 450 in the village. There are 30 ST families, 33 SC families and 52 other caste families . The village isbsituated at a distance of 15 km from the block head quarter. 11 Children within the age group of 3 to 6 years of the village are in the pre schooling stage .On 22nd August, 1992 an Aangan Wadi center was stated in the village. Miss Bishnu Priya Naik was appointed as the worker of the center. But she was subsequently got promotion as the Aangan Wadi Supervisor. In October, 2009 she resigned and thus there was no more worker for that particular post for long period and the center was managed by a helper. After a year Lephripada ICDS took an initiative to fill up the vacancy. Some eligible candidates applied for the post and finally Gomati Majhi was selected by the ICDS as new AWW but due to her lower educational qualification some of the villagers protest her. They demanded to appoint another eligible candidate of their choice for the center. But as the candidate could not show her residential certificate the ICDS did not permit her as the AWW. After that, the villagers locked the AWC and the parents are advised not to send their

children to the AWC. The matter was taken to the ICDS, CDPO, DSWO but no action was taken off.

Mean while SEWAK launched the CRY Project in the area. The project staff involved in the matter and discussed it at the village meetings. They also raised the matter at the level of ADM, Dist. Collector and Assembly (through local MLA). Then the BDO Lephripada, CDPO Lephripada, Tahsildar and some police personnel made a visit to the village and the lock of the Angan Wadi centre was broken in their presence. They instructed Gomati Majhi to open the center regularly. They also requested the villagers to cooperate the AWW. Presently the centre is running smoothly. The children of the village are going to the centre as before and receiving the benefits of AWC.



PR members Training



With the support of the State Institute of Rural Development, Bhubaneswar, SEWAK had been selected as the Collaborative Partner Organization (CPO) for conducting Field Level Capacity Building Training for the newly elected PR members in three blocks named Tangarpali, Lephripara & Balisankara of Sundargarh district. All the elected Sarpanchs, Samiti Members & Ward members had participated in the trainings.

The objective of the training was to orient the PR members on their roles & responsibilities and different govt. schemes like MGNREGA, Mo Kudia, BRGF, SGSY,NRLM,IAY,CCROAD,FRA, Gram Sabha & Palli Sabha, PDS, PMGSY & NRHM etc.

District level Resource Person is empanelled with SIRD to facilitate the training programs.

Prime Minister's Employment Generation Programme (PMEGP) is a new credit linked subsidy programme for generation of employment opportunities for the rural artisans/ unemployed youths through establishment of micro enterprises in rural as well as urban areas.

The Entrepreneurship Development Program (EDP) contains topics like systematic approaches, costing, pricing and profit management, TAT, material management, accounts and book keeping, quality management, IT factors, sustainability precautions, product diversification, designing and packaging, marketing strategies, sale tax and income tax provisions and so on. At the end of the session, the trainees were taken to a successful enterprise for an exposure.

SEWAK with the support of the Khadi and Village Industries Commission (KVIC), District Industries Centres (DICs) and banks implementing the programme. In the year 2012-13, 89 Entrepreneurs had received training, in which 73 were participated in the 15 days training and 13 of them were participated in 3 days training programme.

ASHAs are local women trained to act as health educators and promoters in their communities. ASHAs are also creating awareness on health and it's social determinants and mobilize the community towards local health planning and increased utilization and accountability of the existing health services.

ASHAs are working since 2006-2007 in our district and SEWAK is providing training for the ASHAs from the beginning. At present 2383 ASHAs are there in Sundargarh district. Due to their cooperation and hard work IMR is 28.7/1000, MMR is 198/ 1 lakh live birth, Institutional delivery is 87 % and Full Immunization is 98% in Sundargarh district. Between 28th October 2011 to 15th January 2012, a total of 848 ASHAs have received 6th and 7th Module training from Tangarpali, Hemgir, Lephripara, Sadar, Balisankara, Subdega, Bargaon, Kutra and Rajgangpur blocks in 31batches.

The major components of ASHA module 6th -7th round II are as follows:-

 Child health, Nutrition, Infant and Young Child Feeding (IYCF), Immunization, accessing the malnutrition, Common child hood problems and the case management, accessing and classifying diarrhea and fever, ARI, birth preparedness, home visits, delivery, new born, planning for work in the community.



Computer training at SEWAK



SEWAK has been running the "SEWAK Institute of Computer Application (SICA)" since 2010 with it's own initiatives. The centre has also got ISO certification (ISO 9001:2008(E). The objective of establishment of the centre is to provide computer training to the rural youths in minimal charges by which all the interested candidates can avail and learn from the institute.

At this time, SICA operates from three centers: SWAK Head office premises at Rangiamunda, Lephripara and Chakarpur in Lephripara block. All the centers have registered high enrollment of students.

SEWAK has joined hands with Centum Work Skills India (WSI) in the year 2012 to provide soft skill training (Sales & Retailer) to the unemployed youth of Sundargarh district. Along with the training support, Centum (WSI) was also providing employment opportunities to the trainees after completion of the training. Only the BPL youths from the rural areas were selected for the training. The training was residential in nature. Each batch was for 2 months. In the 1st batch 22 nos & in 2nd batch 19 nos. of trainees had received training. Out of 41 trainees 17 were engaged at Bilwara Text Tile mill (Rajasthan). After placement all 17 trainees are getting income @ Rs.7000/-to Rs.9000/-per month.

For efficient management of water, power and other inputs as well as subsidy to maximize agricultural production on a sustainable basis the Bringing Green Revolution to Eastern India (BGREI) was initiated. The aim of the BGREI program is to harness the water Seed Treatment campaign:

potential for enhancing agriculture production in Eastern India which is under utilized. The program will be implemented in the delineated BGREI districts only adopting cluster approach for convenience and cost effectiveness. The size of each cluster for all the interventions including block demonstrations of rice & wheat shall be 1,000 ha.

SEWAK had been involved in the BGREI-RKVY programme since 2011-12. During 2012-13 the programme was being implemented in Lephripara block in 4 clusters named Giringkela, Telendihi, Karadega & Sargipali.

Irrigated Hybrid Paddy (KRH-2) was cultivated in 1000 ha and among that 102 ha was cultivated in SRI Method and the rest 898 ha was done line transplanting.

Total 922 farmers were involved in the programme and among them 92 are SC, 497 are ST, 333 are general and 95 were of women farmers.



Govt. of Odisha under the Rastriya KrusiVikasYojana (RKVY) started the Seed Treatment Campaign or Seed dressing in the state. The campaign is a chemical, typically antimicrobial or fungidal, with which seeds are treated (or "dressed") prior to planting. Seed treatments can be an environmentally more friendly way of using pesticides as the amount used is very small. SEWAK with the cooperation of Agriculture department implement the programme in 14 villages of 3 blocks in Sundargarh district namely Sadar, Subdega & Balisankara blocks.

Under this programme, SEWAK had organized awareness campaign for the farmers in the area with the district officials on Seed treatment. An awareness Ratha was used for the awareness of the farmers through Miking and the farmers were supplied free medicines for the seed treatment.
