

ABOUT THE ORGANIZATION

THE GENESIS

The district of Sundargarh with an area of 9712 km2 is the second most expansive district in the state of Orissa. Its Schedule Tribe population accounts for 50.69% of the total. The cultural profile is prominently rural and tribal. Over 66% of the population permanently settles in 1744 colorful villages dotted across its territory. The district is exceptionally rich in natural forest (43% of the land is under forest cover), mineral, land and water resources, but this profusion hardly ever reveals itself in the lives of its illiterate and unskilled rural folk who merely survive as poor and vulnerable communities.

A group of youth from different parts of Sundargarh district, inspired by the then Youth Coordinator of Nehru Yuva Kendra Sundargarh Mr. Gopal Chandra Ojha started working collectively in 1995. With the support of the DRDA through the NYK Sundargarh few skill training programmes for the rural youth, plantation and nursery rising, formation and promotion of SHG groups were the initial activities by this group. On 15th May1995, SEWAK was registered under the Registration of Societies Act, XXI of 1860 at Sundargarh. Gradually by 1998 SEWAK Complex became the center of excellence for youth services in Sundargarh. SEWAK was the destination for more than 300 youth organizations.

Up to 1998 NYK Sundargarh was the resource mobilizer for SEWAK. With the transfer of Mr. Ojha to other district as the Youth Coordinator this chapter closed. The SEWAK management then struggled for resources. But the coordination with the district administration and the linkage with the Youth organizations of different parts of the district helped them to survive. During 2005 SEWAK came in contact with the Concern Worldwide India, Bhubaneswar, a Dublin based INGO which was a turning point for the organization. The handholding support provided by this organization really given a professional touch to SEWAK.



LIVELIHOODS & GOVERNANCE

Facilitation of Community Forest Right (CFR)

Community Forest Rights recognized under the Forest Rights Act are important for securing livelihoods of the forest communities and for strengthening local self governance of forests and natural resources. SEWAK has also been a part of the CFR link with the support of FES, Bhubaneswar since 2012. The objective of the intervention is to expedite the process of Community Forest Rights & Community Forest Resource Rights claim in Tangarpali & Bargaon block of Sundargarh district.

Overall Process

- Step-1: Reconstitution of Forest Right Committee as per FRA amendment rule 2012
- Step-2: Preparing the Claim document-and filling of form 'B' & 'C"
- Step-3: Joint Verification
- Step-4: Final Gram Sabha& SDLC submission

Achievement

- Reconstitution of Forest Right Committee as per FRA amendment rule 2012:- 140 nos.
- Claim document preparation and filling of form "B" & "C":- 110 nos.
- Joint Verification: 52 nos.
- Final Gram Sabha& SDLC submission :- 52 nos



SOCIAL AUDIT



The basic objective of a Social Audit is to ensure public accountability in the implementation of projects, laws and policies. One simple form of social audit is a public assembly where all the details of a project are scrutinized. However, 'Social Audit' can also be understood in a broader sense, as a continuous process of public vigilance.

Social Audit on BRGF/IAY-Mo Kudia/CC Road

In the month of November 2013 (25th to 30th November 2014), Social Audit on IAY/Mo Kudia, CC Road, and BRGF were facilitated by SEWAK in 39 Gram Panchayats of Hemgir, Lephripara, Tangarpali and Balisankara Blocks. In those Social Audits, different issues were identified and presented in the public hearings.

Social Audit on MGNREGA

An innovative feature of the Mahatma Gandhi National Rural Employment Guarantee Act is that it gives a vital role to 'Social Audit' as a means of continuous public vigilance (NREGA, Section 17).

In Sundargarh, a significant initiative was taken by the district administration for conducting MGNREGA Social Audit.

SEWAK had facilitated the Social Audit Process in Lephripara, Hemgir, Tangarpali and Balisankara Block in Sundargarh district. In the month of October 2013, it was done in 48 Gram Panchayats of Lephripara, Hemgir, Tangarpali and Balisankara Blocks. Different issues like delay payment, registration and issuing of new job cards, work site facilities came out during the Public Hearings.

TRICKLE UP (Breaking the cycle of extreme poverty)

Trickle Up since 2007, join hands with SEWAK to implement the programme. It is specifically tailored to meet the unique needs of women and families living at extreme levels of poverty. By providing a small bit of capital, known as the Trickle Up Spark Grant, and vital financial and social services, we help participants create opportunities that can break the vicious cycle of poverty, empowering the poorest to achieve a sustainable level of economic stability. SEWAK is implementing the Trickle Up Program in 3 GPs of Bargaon block comprising 11 villages and 24 hamlets by covering 300 ultra poor families .Major objectives of the project were:-

- Sustainable Livelihood through creation of land and water based asset for increased income
- Community based organization (Self-Help Group and Clusters) for Social and economic empowerment
- Health intervention to create enabling environment for life and livelihood
- Reproductive Child and Mother Health
- Adolescent Health

Major achievements of the project

- Out of 300 PPs 42 % PPs earned profit above Rs 22,000/-10%earned profit above Rs 15,000/-, 23 % earned profit above Rs 10,000,9 % earned profit above Rs 8,000 & 16% earned profit above their investment.
- 22 numbers of collective actions taken by the SHGs against liquor shop, domestic violence, accessing benefit, conflict resolution etc.
- 144 numbers of PPs purchased productive assets like water pumps, sprayers, bullocks, sewing machines.
- The largest increase in proportion of participants using family planning measures was 29 % to 57 % (Out of 133 total done 69)
- Use of mosquito nets increased from 7% to 86%
- Institutional deliveries increased from 18% to 95%
- Most participants invested the TU grant in more than one livelihood activity. The most popular combination of activities was agriculture and goatery.



Self Confidence makes the fortune.....

Elisaba Bhengra is a resident of Petford (Mundapara) of Bargaon block. She is an unmarried and differently able lady. Her family includes her elder sister, widow sister-in-law and three little children. The family is headed by her. They have no land, the family depends upon the disability pension and PDS. The family was going through a critical economic condition. Elisaba was under pressure. Their future was uncertain.

In the mean time, Trickle Up programme was planned to be implemented in the area. It was like a blessing for Elisaba. She was selected as a project participant (PP) of the program and was motivated and counseled by the project staffs. She has started a Small Business by selling Chana, Mudhi etc and purchased 2 goats.

After few months, with the support and supervision of the Trickle Up staffs, now she is earning Rs. 100/-per day. Her monthly income is Rs. 3000/-. She has saved Rs. 7800/- in the SHG and saved another Rs. 3000/-. Now her confidence level is high and she is managing her family as well.

Now she is planning to expand her business and save money for her nephews, so that they can avail good education.



CBSA...... Save Forests and Forests will Save You



The Vana Surakshya Samities (VSSs) has a significant role in Joint Forest Management (JFM). SEWAK is working with 550 VSS through Capacity Building Support Agency (CBSA) in Deogarh, Bonai & Rourkela forest divisions since 2011.

Under this SEWAK has been providing complex learning, adaptation and attitudinal change at the Individual, group and organizational levels. In the first phase of deployment of CBSA, we have carried out activities to assess the needs, improve project process and performance as well as monitoring of the influence of improved capacities on results of those processes.

In the 2nd phase, the CBSA is deployed for developing the capacities of the 1st& 2nd batch VSS.

Major achievements

- Covered Capacity Building Development Programme in 280 VSSs
- Organized 232 training programmes on Accounting and Book Keeping, ANR Under planting, SMC and Thinning.
- Organized 28 Exposure Visits of the VSS members
- Developed Modules and Training Materials on Accounting & Book keeping, Soil Moisture Conservation, Under Planting in ANR, Tending & Thinning

Partner NGO

Odisha Forestry Sector Development Project (OFSDP) lunched on 31st March 2006 with assistance of Japan International Cooperation Agency (JICA). The Project aims at Restoration of degraded forest and sustainable Development of the tribal community/habitats near the forest demography through community empowerment, Income Generation Activities and Livelihood improvement.

The duration of the Project period was for 7 years from 2006-07 to 2012-13. SEWAK has been associated with the OFSDP project since 2012-13, SEWAK was selected to implement the Partner NGO programme in Bonai & Rourkela forest division covering 12 Forest Ranges / FMUs. During first 3 years, project had involved the NGO partners for entry point activities. But later project seek to address livelihood augmentation and capacity building need in the consolidation phase.

NGO supported programmes for the PVTGs



Particularly Vulnerable Tribal Groups (PVTGs) are the most vulnerable community habited in Lahunipara block of Sundargarh district. For the development of the PVTGs, the Paudi Bhuyan Development Agency (PBDA), Khutgaon has been working from the last 34 Years. PVTG Micro Project take-up area consists of 22 villages having 1016 HH from 05 GP of Lahunipara Block. SEWAK has join hands with PBDA in the year 2013 and implementing different development programmes.

Programmes undertaken in the area:

- Reform and reorganize 40 no's of SHG.
- Capacity Building of SHG.
- Training on sericulture.
- Training on Horticulture based Plantation.
- Training on Backyard Poultry to 50 no's of beneficiaries.
- Training on Goat Rearing to 25 no's of beneficiaries.

- Dissemination of IEC materials

OTELP (IN PVTG MICRO PROJECT AREA); - ST/SC development department, Govt. of Odisha select SEWAK as the partner/field level NGO to facilitate the PBDA, Khuntgaon for the successful implementation of the OTELP programme from the year 2013. SEWAK has done a base line survey of that 22 villages and 16 no's of hamlets. The Detail Project Report (DPR) has also been submitted to the department. IFAD is conducting time to time field visits.

FADP

In the year 2013, SEWAK is selected as the Field NGO (FNGO) to implement the Focus Area Development Programme (FADP) in Sundargarh& Bonai ITDA covering 13 blocks of Sundargarh district. The objective of FADP is to strengthen the socio-economic development of ST families through implementation of various livelihood enhancement projects with "Individual family/Group intervention. The livelihood enhancement projects to be undertaken are:

- HORTICULTURE, WADI; which is meant for Orchard development of Mango, Banana, Cashew, litchi, Medicinal plants, Hill Broom and Lemon. Intercropping is a prime component here.
- Poultry Farming: Backyard Poultry (Banraj), Broiler, Layer, Night Shelter and Mother Chick Units (MCU) are the models. In this project the beneficiaries are supported with 28 days old chicks, drinker, feeder, liter etc. It is planned, for every 1000 chicks; there will be a Mother Chicks Unit (MCU). Total 300 SHG members of Gurundia & Bonai block were supported with 30 chicks each under this scheme.

 Fishery:-The beneficiaries are supported for the fish farming in both Individual and Group models.

NTFP:-Under this, construction of Drying Yard and Production unit are the m a i n components.



 ME:- For Establishing Micro Enterprises (ME), ST WSHG's are encouraged by this project.

Promotion and Linkage of Women SHGs in Backward District: Since 2013, SEWAK has been implementing the Promotion and linkage of Women SHGs programme in Lephripara, Bargaon & Kutra block of Sundargarh district supported by NABARD,. The objective of the programme is to form the SHG groups of the most unprivileged and deprived women in the society, and those who are not included in any group. Along with the formation of the groups these are also linked with Banks. In total 150 SHGs are formed in in these three blocks.

HEALTH SECTION

Mother & Child Health programme

To improve the Reproductive & Child Health condition by strengthening the service delivery mechanism in the periphery villages of Lanjiberna, SEWAK in the year 2013, tagged with the CSR wing of OCL India Limited, Rajgangpur. The project covers 4 GPs/8 villages of Rajgangpur block and 2 GPs/4 villages of Kutra block covering 15,775 population. The project basically focuses on the Pregnant & Lactating mothers, Children, Adolescent groups& eligible couples.

Major objectives of the project are:

- To ensure 100% registration of pregnancy, 90% complete ANC and 70% complete PNC by improving the service delivery mechanism.
- To ensure 90% complete immunization for children less than 02 years through regular service and social mobilization.
- To increase the use of modern contraceptives among eligible couples through social mobilization.
- To decrease the prevalence of RTI and STI through education to the adolescents and increase institutional health seeking behavior.
- To improve the service delivery system of health, through capacity building, networking and co-ordination.
- To reduce the rate of infant and child mortality by addressing the issue of malnutrition.

Major achievements

- 99% complete immunization.
- 95 Eligible Male willing to adopt temporary methods of contraceptives.
- 04 GKS are conducting their meetings on a regular basis and developed realistic health plans.
- 98% live birth recorded.
- 82 nos. of malnourished children are improved to better health.
- 7 nos. of Kishori Samuhas are regularly conducting their Saturday sessions.



Exclusive breast feeding is the key to healthy baby

Carmela Dung Dunga 10thpass lady got married at the age of 28 to Prafulla Kumar Dung Dung of Bhuyanpada. Prafulla is working as a labour at OCL, Rajgangpur. Her family includes mother-in-law, sister-in-law, bother-in-law and her little son.

When Carmela was pregnant she was at her mom's house because of the mental disorder of her mother-in-law and also there was no responsible person at her home to take her to hospital in the emergency/delivery time. She delivered her child on 7th Aug, 2013 at the Govt. Hospital Rourkela. With the advice of the nurses she gave her colostrums to the new born baby within one hour of delivery. After two days she returned back to home but not attended the VHND. During the door to door visit, SEWAK staff asked her about the reason of non attendance in the VHND and she replied that, due to the low weight of the baby her family members were dissatisfied with her. Then Ms. Lipika Guhal, Community Organizer counseled her to attend the VHND and also made her understand about the exclusive breast feeding, conversation with the child during breast feeding, supplementary food after 6 months.

After that, on 4th Oct, 2013, Carmela attended the VHND. The baby was measured and it was 3 kg. Carmela was happy with the improvement of her baby and shared with other mothers that, due to the exclusive breast feeding the baby has gained proper weight and has been urinating for 10 times daily, which is an good indicator. Now her family members are also happy.



HIV / AIDS (Don't die of ignorance)

A. Targeted Intervention(TI)

HIV/AID is just like forest fire, it is an alarming factor for all the nations in the world. MSM & FSW are the most High Risk Groups in the transmission of HIV/AIDs across the globe. The main reason of the transmission of HIV/AIDs is due to lack of awareness among the people on HIV/AIDs. Rourkela is one of the busiest cities in Odisha and also a hub of livelihood sources. SEWAK has been implementing the Targeted Intervention project on HIV/AIDs in the urban area of Rourkela supported by Odisha State Aids Control Society (OSACS) since 2008. 200 MSM & 300 FSWs are being targeted by the project.

Major objectives of the project are: To increase effectiveness and efficiency of service providers for strong governance to ensure quality service. To provide innovative and effective BCC to FSWs, MSMs, and other stake holders of the community. To control the high risk behavior of the target group To promote the correct use of the condoms and preventive measures To make the client aware intensively on the subject To create a pro enabling environment To ensure social mobilization for the community empowerment To make accessible for existing and ongoing health services To ensure lobby and advocacy for the target population

Major achievements

- 321 FSW and 213 MSM registered
- 695 FSW and 641 MSM referred
- 429 FSW and 471 MSM HIV tested
- Total 4 positive cases are identified
- 1171 FSW and 944 MSM provided RMC
- 23 FSW and 9 MSM are treated for STI
- 2 SHGs are formed by the FSWs



B. Transit Migrant.....

Rourkela Railway station is catering thousands of migrant transaction. The migrants have been staying out of home for months and years together and thus attracted towards



FSWs or MSMs. Through this programme, the outreach workers are generously creating awareness on HIV/AIDS among them and counseling them for a safe sex in case they are doing so. This year as many as 4686 outgoing migrants and 563 in coming migrants (Total 5249) were covered through the programme in which there were 129 female migrants were included.

C. Learning Site

For the development of learning sites, capacity building and transfer of best practices, Tamilnadu AIDs Initiative (TAI) joined hands with Odisha State

Aids Control Society (OSACS) in May, 2013 and the programme is known as 'South to North' program. SEWAK has been selected as the learning site for the Western zone which covers 05 TIs



(working for MSM & FSWs) in Sundargarh, Sambalpur, Jharsuguda, Kalahandi and Deogarh district.

The objectives of the programme are:

- Select development and strengthen the capacity of Targeted Intervention NGOs as learning Sites.
- Strengthen the capacity of allied services providers and TI NGOs linked to the Learning Sites.
- Build the capacity of non TI NGOs for mainstreaming HIV and applying for TI projects.

D. Pehchhan..... An identity to the MTH Community

To strengthen the MTH (MSM, Transgender & Hijras) Community in Sundargarh district, SEWAK is implementing a project named "Project Pehchhan". The project is covering whole Sundargarh district but presently operational in 06 blocks and Rourkela municipality. A Community Based Organisation (CBO) named "Milita Paribar"is formed. The project is supported by SAATHII, Kolkata since year 2013. The main aim of Pehchan Project is to maximise the role and contribution of community action to halt and reverse the spread of the HIV epidemic.



Pehchhan saved my life....

Md. Muraad belongs to the MSM Community (Transgender) is known as 'Bipasha'. Few months back she has been sexually absued by a group of local Gundas at Nalaroad,



Rourkela. But she did not disclose the matter to any body and was depressed and planned for committing suicide.

Fortunately in the mean time one of the Pehchhan PFO named SK. Amanullah met her. At that time both of them were unknown to each other. By observing Bipasa's activities, SK. Aman tried to talk with her but Bipasha ignored him. After a short gap SK. Aman again met her and built-up friendship. As a result Bipasha shared all the matter to SK. Aman. Then she was counseled by him. Bipasa was gone through a Trauma-Violence Counseling, and as a result Bipasa was able to clearly understand the reality of life and changed her decision.

Now she is coming to the Pehchhan Office regularly and giving her best support to the project. Now she has been appointed as a volunteer of Pehchhan Project, working sincerely.

Fighting against TB, one of the greatest enemies of the mankind.

With a goal to reduce the Tuberculosis in Sundargarh district, SEWAK has been selected as the Sub- Sub Recipient (SSR) of Global Fund to implement the Axshya India GF9 TB Project. Lepra Society is directly supporting for the programme since October, 2010. The programme is being implemented in two TB Units of Sundargarh district which includes Sadar & Sargipali TB Unit and both the TUs cover6 blocks of the district in which there are 79 GPs & 458 villages. The broader objectives of the project is:

- To enhance the capacity of the community on 70% case detection and 85% cure rate in Sundargarh district.
- To have an early case detection and ensure complete and full treatment.

Major initiatives undertaken:

- Creating awareness level of the community i.e. WSHG,GKS, Youth Clubs on RNTCP
- Developing basic knowledge on TB, its sign & symptoms.
- Making a clear understanding of the community members through participation of RNTCP so that there will be increase in case detection, early & complete treatment.



Finally Mahendra escaped death:

Mahendra Tanty, age 60, is a resident of Telendihi village and living with his small family. As he was working in a electric construction company his economic condition was good. His earning was good but he was addicted to alcohol. Excessive consumption of alcohol made him weak. Gradually symptoms of TB are found with him and his condition was getting worse day by day. At last he had visited to the doctor and prescribed with DOTS.

After two months he discontinued the medicine. Repeated discontinuation of medicines made his condition more critical. When he was seriously ill and unable to move, he was admitted at DTC, for a week long, Doctor strictly advised him for continuing medicine. His family members requested the GKS of the village for their support for the treatment. In the initial stage GKS was not ready to support because of the attitude of Mahendra, but later they agreed. Mr. Rajkumar Deheri has taken the responsibility of his continuous treatment and at last he made agree the Mangaspur Medical Officer In Charge, STS /STLS for their support. With a joint effort of ASHA, Ward member and NGO staff she received proper checkup, card valediction& medicine. Also the village ASHA has taken the responsibility for regular visit and ensured taking of DOTS. Along with this Dist. Coordinator and SDPS were monitoring the patient regularly.

Now Mahendra is recovering and is committed to complete the dosage .He has also promised that, he will be a DOTS provider and work against TB in his village and society. GKS members are also planning for Wall painting and a rally in controlling TB at their village.

Vulnerable Community Programme:

(A special initiative for improving health of vulnerable)

The Particularly Vulnerable Tribal Groups (PVTGs) are the most vulnerable sections identified by the ST/SC department, Govt. of Odisha. They are residing in 17 pockets of Odisha. One such group is known as Paudi Bhuyan residing in the periphery of Khandadhar Water fall of Lahunipara block in Sundargarh district.

The RCH indicators of vulnerable population are very low than the District/ State average. Thus NRHM has taken initiatives to address the health/RCH issues of those areas with focus attention on strengthening capacity, effectiveness and participation of civil society, with specific recommendations of District Health Authority and other stakeholders.

SEWAK has been selected to implement the Vulnerable Community Programme in 12 villages-of Talbahali & Kuliposh GP of Lahunipara block since 2013 with the support of NHM.

Major Components under the programme:-

- Maternal Health ANC, PNC, Promotion of institutional delivery, referral transportation during the emergency, VHND, outreach camps, RTI/STI screening etc.
- Child Health Immunization, Pustikar Diwas, School health programme.
- Family Planning Promotion of temporary and permanent FP methods, counseling etc.
- Adolescent & Sexual Reproductive Health -Formation of Balika Mandal, sensitization of life skill education, personal hygiene, deworming, IFA etc.



- Communalization process Strengthening of ASHA & GKS activities, facilitate in preparation of GKS Health plan, development of kitchen garden, reward & reorganization etc.
- IEC/BCC Observation of different designation days at community level, mass IEC campaign, wall paining.

Maa Gruha

("The Maternal Home" A special initiative for mothers of inaccessible pockets)



The NHM is working in a mission mode to reduce the IMR & MMR and promoting institutional delivery. But the expectant mothers of inaccessible area are not able to reach the hospitals due to poor communication, resulting Mother or child mortality. Thus the concept of Maa Gruha came out. It is a temporary home for the expectant mothers where they can wait for safe delivery.

SEWAK is running one Maa Gruha since 2013 in Lephripara block for the people living in most difficult pockets. From 8 Sub Centers of the block the expectant mothers are coming. The mothers are referred to the nearest hospital for their delivery i.e. Sargipali CHC, Gundiadihi, Lephripara& District Head Quarter Hospital, Sundargarh. Total 6 beds are available at the Maa Gruha and during the stay all the mothers are supplied with healthy & nutritious food. Total 312 mothers have been served through this Maa Gruha during 2013-14 and ensured institutional delivery.

During their stay, the mothers are being sensitized on colostrum feeding, Institutional delivery, good health & hygiene practices, Pre & Post Natal Care, Child Care & family planning by the staffs of Maa Gruha.

SABLA (Empowering the Adolescent girls)

The Rajiv Gandhi Scheme for Empowerment of Adolescent Girls (RGSEAG) or the SABLA programme is a step forward to address the adolescent health issues through varied strategies and approaches as per the need of the hour. The Scheme has an integrated package of activities intending towards the empowerment of the Adolescent Girls in the age group of 11-18 years and improving the health & nutrition status of these girls.

SEWAK, since 2012 has been implementing the SABLA programme with the support of W & CD Dept. Govt. of Odisha and covering all the 21 ICDS units of Sundargarh district in a network mode with partner NGOs.

The objectives of the programme are:

- Enable the Adolescent girls for selfdevelopment and empowerment.
- Improve their nutrition and health status.
- Promote awareness about health, hygiene, nutrition, adolescent reproductive and sexual health (ARSH) and family and child care.
- Upgrade home-based skills, life skills and integrate with the National Skill Development Program (NSDP) for vocational skills.
- Mainstream out of school adolescent girls into formal/non formal education.
- Provide information/guidance about existing public services such as PHC, CHC, Post Office, Bank, Police Station, etc.

Major Achievements

- 77 batches of training completed across the district.
- 1,070 Kishori Samuha participated in the training.
- 3,129 Sakhis & Sahelis received training
- 20,134 Sakhis & Sahelis participated in the Exposure visits.



Community Led Total Sanitation (CLTS):

A new approach to sanitation.

For the last three decades government has been trying different models on sanitation. But till date there is little visibility in the work. Even now more than 65crore people are doing open defecating leading to various health hazards.

With the support of DFID-TMST the Knowledge Links, New Delhi initiated a new approach named CLTS (Community led total sanitation) in which government or no other agency will only facilitate a process of triggering. One meeting in a village is sufficient to mobilize the people. Then community will stop open defecation from the next day. They may construct toilets in their own cost without waiting for any subsidy or grant from the government.

SEWAK is also a part of the programme and implementing the programme in Kuarmunda block of Sundargarh district.

Urban Slum Health Project

SEWAK is running a Tier-2 Urban Health Centre at Tikanagar, near Bondomunda in Rourkela from 1st November, 2007 as a Tier-1 UHP and upgraded in the subsequent year. The project covers 23004 populations of the 18 slums of Rourkela. Through this centre a range of health related services OPD, referral, laboratory testing, awareness generation, community mobilization, BCC, health camp, adolescent training, social marketing are being provided to the slum dwellers like

EDUCATION & CHILD RIGHT SECTION

Shikshya Chetana (Education makes a difference)

Still in rural Odisha education has a least priority. To bring the children to school and encourage the community to be a part of education, SEWAK is working on it since 2008, as a part of Shikshya Chetana Programme. The programme is being implemented in 2 GPs (Meghdega & Gambharidihi) of Tangarpali block. Major objectives of the programme are:

- To ensure 100% enrollment and retention of 6 to 14 years children in the schools with the community participation
- To strengthen & motivate civil society organization to make the village people understand the importance of relevant quality education
- To facilitate lobby & advocacy at panchayat and block level to bring about policy changes in the present education



CRY (A Child right initiative)

With the support of CRY, Kolkata, since 2012, SEWAK has been implementing the Child Rights Project in Lephripara block in 2GPs and 19 villages.

The major objectives of the project are:

- To reduce the rate of Malnutrition.
- To ensure quality education.
- Ensure eradication of working children and regularizing their school education in the age group of 6-14 years.
- To ensure child participation in decision making process.

Major achievements of the project are:

- 300 (0-5 years) children received complete immunization.
- 10 new ICDS building constructed.
- 2000 children are enrolled in different schools.
- 5 boys and 6 girl dropout children enrolled in schools
- 15 % retention rate increased in the project area
- 4 SMCs regularly participating in school development process
- 1 case of child abuse has been sorted out in the project area



Janch Committee made the AWC functional.

Bandhlikani is a small remote village in Masabira Gram Panchayat in Lephripara block of Sundargarh district. The village is encircled by dense forest & mountains. It is around 21 kms from Lephripara block headquarters and 40 kms from Sundargarh district headquarters. Total 110 household are residing in the village. Major sub-castes in the village are Dhoba, Kuanr, Bhuyan, Mahakud, Luhura and Dhanuar.

Till 2011, the Anganwadi worker did not come to the school regularly and the children & mothers were also not getting the provisions of the ICDS like THR, immunization, Health services, and observation of Mamata Diwas. Meeting of the Janch committee and mothers committee had never been organized in the village before.



In 2011, SEWAK has intervened in the area through CRY project and capacity buildings of the Janch Committee were done. The members were oriented on their roles & responsibilities. As a result the monthly meetings are regularly happening. Prior to this only one or two participants were participating in the meeting but the attendance of the participants has increased. The AWW is also coming to the AWC regularly and the ICDS beneficiaries are getting all the benefits of the ICDS.

PR members training

SIRD is the State Nodal Agency on behalf of the PR Dept. Govt of Odisha to carry out the PR members training programme across the state. In the year 2008, SEWAK has been selected as the Collaborative Partner Organization (CPO) for conducting capacity building of the PR members in Sundargarh district. During 2013-14, SEWAK has organized capacity building for the PR members of Lephripara, Tangarpali, Balisankara & Hemgir block. In the 2nd phase total 219 PR representatives from Balisankara & Hemgir had received training.

EDP training (Entrepreneurship Development Programme)

To create employment opportunity in the rural and urban area, the Prime Minister Employment Generation Programme (PMEGP) scheme has been enacted across the country from 15th August, 2008.

SEWAK is implementing the Entrepreneurship Development Programme (EDP) since 2011 with the support of Khadi & Village Industries (KVIC), District Industries Centre (DIC), Sundargarh and banks.

During 2013-14, total 56 entrepreneurs had received the Entrepreneurship Development Training from SEWAK in 3 batches. Two batches of training are of 15 days and 1 batch of training is of 3 days. The trainees were from the urban, slum and rural areas of Sundargarh DIC & Rourkela RIC.



Major topics covered in the training were:

- Entrepreneurship: Charms & Challenges
- Risk taking behavior
- Problem solving & creativity
- Communication, leadership
- Accounts & book keeping
- Managing the enterprise: purchasing, inventory/ material management, quality management, designing and packaging, man power management
- Costing, pricing and profit management
- Marketing strategy and sales techniques
- Sustainability of an unit precautions
- Product diversification and expansion
- Crisis management & IT factors

Skill Training under SDI



Government of India, Ministry of Labour & Employment launched a Modular Employable Skills (MES) under Skill Development Initiative (SDI) Scheme through Directorate General of Employment & Training in May 2007. Under this scheme, training to earlier school leavers and existing workers especially in the un-organised sector are to be trained for employable skill.

SEWAK on 16th March 2012 is registered as the Vocational Training Provider (VTP). As a VTP, SEWAK is implementing the Tailoring and Hand Embroidery training for the ladies. During 2013-14 two batches of training were conducted comprising 40 trainees.

ASHA Training:

Capacity building of the front line health workers.

One of the greatest contributions of National Health Mission (NHM) to the country is an Accredited Social Health Activist (ASHA) for every 1000 population. Selected from the village itself and accountable to it, the ASHA is an interface between the community and the Public health system. In Sundargarh district there are 2383 ASHAs. SEWAK has been engaged in capacity building of the ASHAs since 2006-2007.

During 2013-14, SEWAK has undertaken the ASHA training in 8 blocks and the following trainings has been undertaken:

Watershed Mission

Capacity building initiatives:

During 2013-14, SEWAK has been tagged with the Watershed Mission, Sundargarh for implementing vocational training to the unemployed youths of the watershed area in Sundargarh district. Trainees across the district had participated in the trainings. The major trainings undertaken by SEWAK were:

Along with the vocational training, SEWAK has also organized the training programme for the Community Level Worker (CLW) of the watershed area. 2524 participants were covered under this across the district.







Nai Roshni.

It is a scheme for Leadership development of Minority women.

The main objectives are:-

Objective 1- Empower and instill confidence among minority women by providing knowledge, tools, and techniques for interacting with government systems.

Objective 2. - Empowerment of women for the minority communities and emboldening them to move out of the confines of their home and community and assure leadership roles.

As this is a pilot phase during this year only three training programmes were conducted in Lephripara block with 82 participants.

BGREI-RKVY

Joining hands for green revolution

"Bringing Green Revolution to Eastern India (BGREI)"- a lateral to Rashtriya Krishi Vikas Yojana (RKVY) intended to address the constraints limiting the productivity of "rice based cropping systems" in 7 states of India, so that agriculture productivity is reasonably enhanced and stabilized in these areas.


SEWAK had facilitating the process in 3 GPs of Tangarpali block i.e. Sanpatrapali, Ratanpur and Tasladihi. Irrigated Hybrid Paddy (KRH-2) was cultivated in 1000 ha in SRI method (line transplanting).

In total 781 farmers were included in this programme.



SEWAK Computer Centre

A low cost solution for the rural youth..



Computer becomes a part and partial of the life, maybe it is personal or public. Computer literacy is a must for every job seeker. But for the rural poor chaps it is an expensive affair. Though there are about a dozen computer centers in the district headquarter, these are not affordable for many of the job seekers as the fees range starts from Rs.7000/-

As a solution to this, SEWAK has started a Computer center in 2010 at SEWAK Complex, Rangiamunda with an affordable fees structure which is as low as Rs.1500/- only. The center has also availed ISO certification.

During 2013-14, total 77 students were passed out from the center. As many as32 passedout students are now engaged in different jobs at company, shop, govt& private offices and earning a good amount.

SICA Computer center: - Ablessing for us....

Bhesaja Singh & Kishore Gartia are residens of Kiripsira GP in Tangarpali block. Both of them were the students of the SEWAK computer center. Their educational qualification is just +2. They were admitted under the PGDAC (VT) & Tally courses at the center.

Now both of them are working at Power Finance Corporation at Kopsingha of Sundargarh district and getting a monthly salary of Rs. 16, 500/-. Now they are supporting their families and are happy.

THEME WISE FUND RECEIVED AND EXPENDITURE





































GEOGRAPHICAL COVERAGE OF SEWAK
