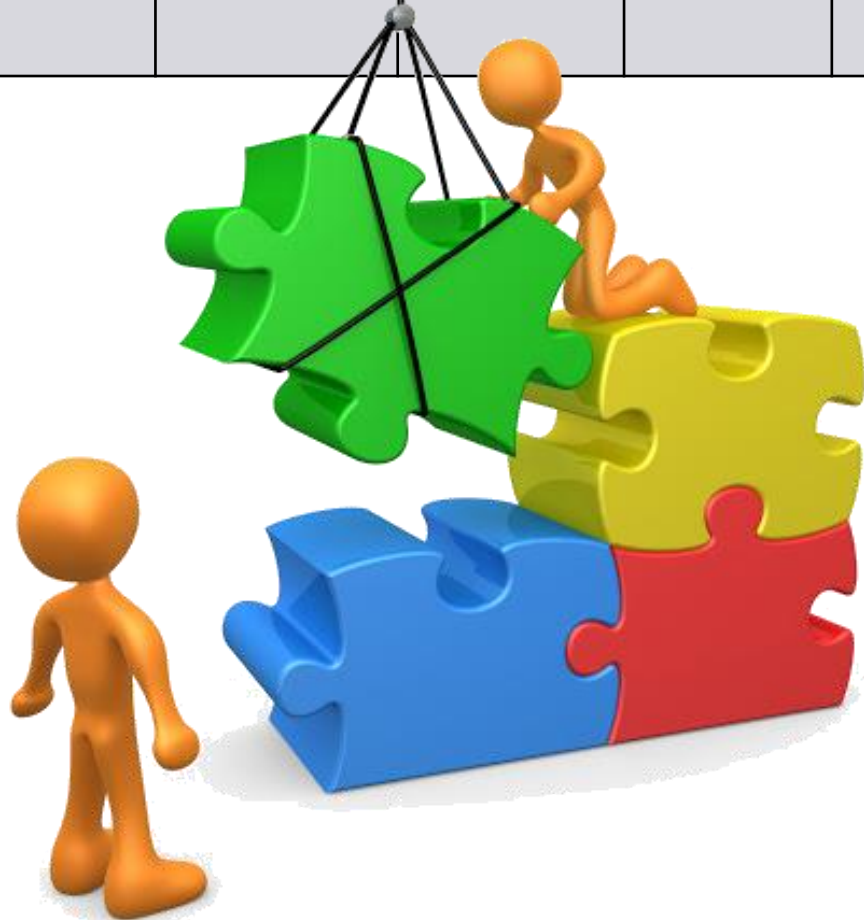

The Rason kit included Atta, Sugar, Flattened rice, Boiled rice, refined oil, Biscuit, Harad dal, Salt, Washing soap, Bathing soap, Washing powder, Curry powder, Onion, and Potato. A total of Rs.1, 59,600 was spent during this campaign.

Distribution of mask to the localites was also carried out

Awareness campaign on proper hand washing and sanitation was carried out through demonstration.
