


Odisha is one of the biodiversity-rich and mineral-rich states in the country. It owns different forest types according to the geographic areas. According to the sources, there are more than 29000 villages established in and around the forests of the state. Similarly, as per the Census 2011, the state of Odisha has the third highest percentage of tribal population in the country. They constitute 22.85% of the total population of the state and contribute 9.17% to the total tribal population of the country. Being an organization established in Sundargarh a tribal-dominated district, in the western part of Odisha we feel proud to work for the socio-economic, education, and health sectors of the Schedule Tribe community particularly.

As per international sources, more than 80% of the global food supply is produced by small and marginal farmers, especially those living in developing countries. And, in the meantime the indigenous grains, millets have been increasingly recognized as the future crops, to ensure food security, especially in the context of deforestation, global warming, and climate change impacts. Looking at the above contexts SEWAK has played a crucial role in establishing conservation and management of indigenous crops, nutrition supply through indigenous food as well livelihood development to the farmers in the recent past. Looking at the development of small and marginalized farmers different projects are being implemented by involving WSHGs, Producer Groups, and individuals too. In this context, many barren, unproductive, and unused lands are planted with horticultural and forest plants where intercropping plays a key role in income generation. Similarly, degraded forest lands are planted under the project connected with the Forest, Environment, and Climate Change Department. We believe it will significantly reduce the human pressure on forests to some extent.

Facilitating the tribal and forest-dwelling communities for right and ownership to the land, water, and forest resources under the FRA, 2006 is an opportunity to establish their identity, and cultural heritage, and implement different government schemes and facilities. SEWAK, being an old player in facilitating FRA is still working on the conversion of forest village to revenue village status in any areas.

Last but not least it will be a misdemeanor if we do not mention and offer our sincere gratitude to the donors, local communities, and government officials for their support. It would not have been possible without the support of our dedicated team, and the guidance of the board members and well-wishers.

- Secure sustainable forest management by improving forest administration, community organization and other stakeholders.
- Conservation and scientific management of the Biodiversity.
- Promoting inter sectoral convergence for enhanced livelihood.
- Improve income of the target forest dependents.

- → Jhurimal VSS of Ujalpur FMU won the Statelevel Biju Patnaik Best VSS Award and launched the first VSS-level website in India, funded by their resources.
- Over a three-year period, 112 VSS remained free from forest fire incidents, safeguarding the forest ecosystem from potential devastation.
- → P-NGO team mobilized 2058 members of 156 VSS for Farm Forestry activities, covering 958.27 hectares.
- ✓ Over the last 5 years, Rs. 62.85 crores were generated through convergence efforts, benefitting 16,263 households across 156 VSS, enhancing economic empowerment and community resilience.

Empower village assemblies to secure their rights to customary forests under the Forest Rights Act. Build capacity to replicate and upscale recognition of community land and forest rights in 9 blocks of Sundargarh dist. & 1 block of Jharsuguda dist. Establish robust systems for socio-ecological monitoring of community lands and forests.



- Through the FRA Special Drive program, the target of reaching 630 villages and covering all 17 blocks was successfully achieved with the support of other CSOs. This extensive effort facilitated the awareness campaign about the Forest Rights Act and CFR Act across the district.
- In 647 villages, activities such as form filling, FRC formation, mapping, and coordination with government officials were carried out.
- Out of 47 CR villages, 9 CFR villages are planned for conversion into Revenue villages by the District Administration.







Forest is central to their lives. And to protect it, VSS members of Jhurimal in Sundargarh district have not only been taking up plantation drives but also reducing human dependence on


